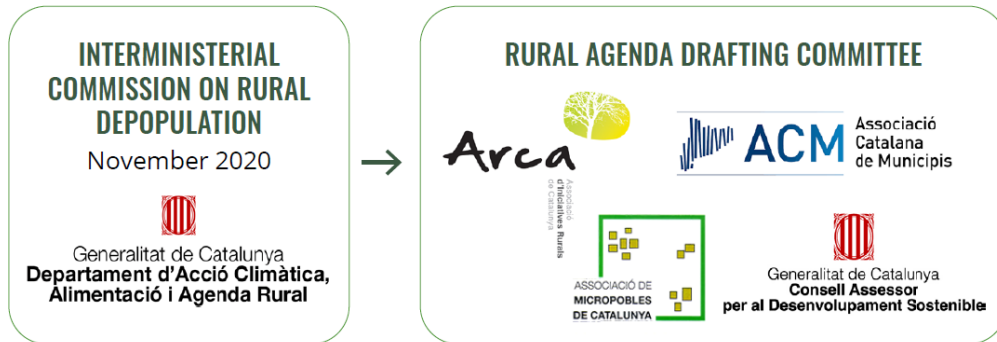

GOVERNANCE OF THE CATALONIA RURAL AGENDA

DRAFTING



- More than 1,200 people and 350 organizations participated in the various workshops all around Catalonia.
- Approval of the Rural Agenda by the Government (May 24, 2022). Commitment to promote actions over which it is competent.
- Modification of the name and functions of the Interdepartmental Commission on Rural Depopulation (July 19, 2022): coordination, implementation, and evaluation of the Rural Agenda.

IMPLEMENTATION

- 1) **GOVERNMENT:** Interministerial Commission on Rural Governance (ICRG) + ICRG Technical Working Group
- 2) **CIVIL SOCIETY:** Rural Pact Steering Committee (35 organisations)
- 3) **PARLIAMENT:** the Rural Agenda Follow-up Commission



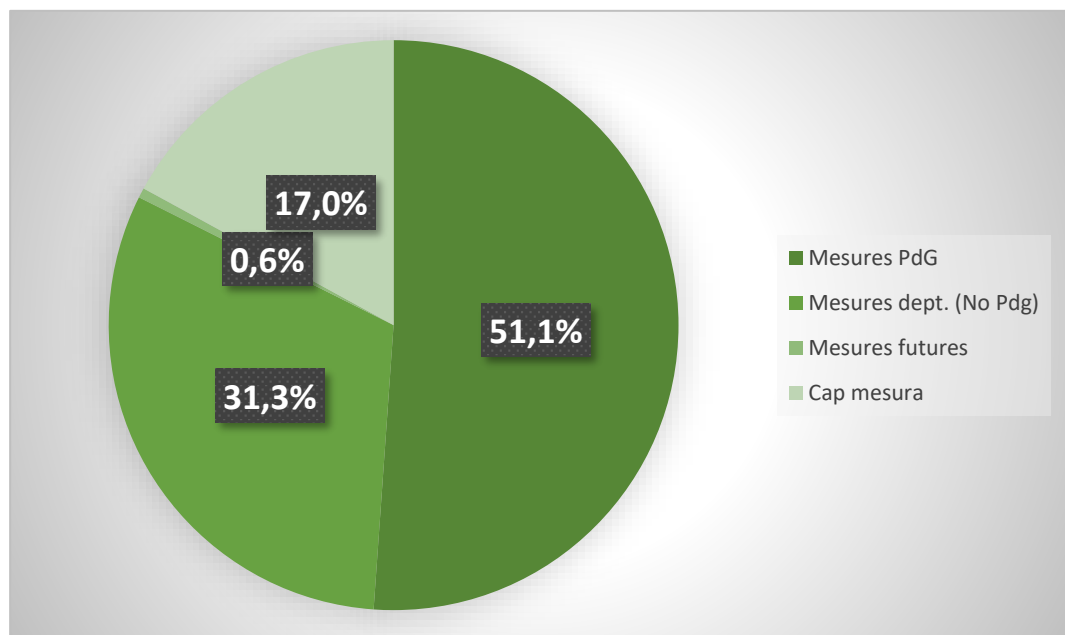

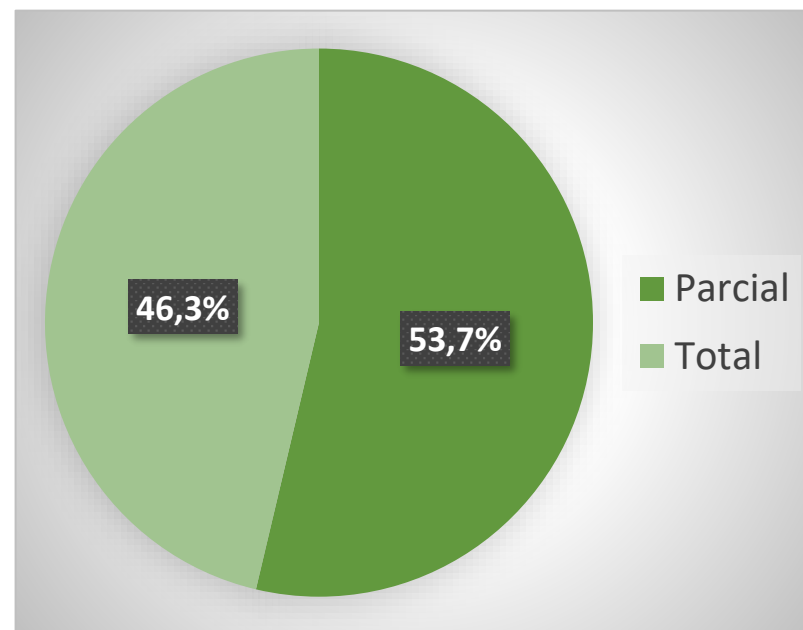


DEPLOYMENT OF THE RURAL AGENDA

- 1) Identification of the current state of the actions of the RA in the Government Plan and in the ministerial plans (2023).
- 2) Government + Rural Pact Steering Committee Working Plan for the prioritized actions (1st semester 2024), starting with the 59 strategic actions and rural Proofing.



82.4% of the actions are included, with varying degrees of coverage, in the Government Plan or in measures promoted by the sectoral ministries.



The ministries consider that the measures under development fully cover 46.3% of the priority actions of the Rural Agenda.
