

WHY THIS REGION?



Beyond mere purification lies a vision of transformation. This realm has the potential to rise as a beacon, illuminating pathways of non-toxic wonders, embracing clean innovations in life and creation.

Historical Context & Urgency

- This region was one of the most polluted in Slovenia, shaped by 200+ years of coal mining, thermal power, cement, and chemical production.
- 30 years ago, local radio advised people to keep windows closed and children indoors due to air pollution.
- Cancer rates in this area are 10x higher than the national average.
- The region carries a negative association of being "black, polluted, and industrial"

Transformation Through the Non-Tox Hub

- Shifting the narrative from toxicity to sustainability.
- Establishing the region as a model for non-toxic, sustainable development.
- Creating a replicable framework for healthy building solutions.





