### Who qualifies for ACORNS?

- ✓ Female entrepreneur living in a rural area as defined by CEDRA. (All areas of the country outside the administrative city boundaries of Dublin, Cork, Galway, Limerick and Waterford).
- ✓ She must have recently set up a new business, which she owns or part owns, or must be actively planning a new venture and have a clear idea of what she wants to achieve.
- ✓ There is no restriction on the sector in which the new business is focused.
- ✓ She must plan to become an employer within three years.



- ✓ Was piloted in 2015/ 2016. Just completed 10<sup>th</sup> cycle
- ✓ More than 3 applications each year for every place available
- ✓ Based on peer support and philosophy of confidentiality, collaboration.
- ✓ Focus on the achievement of goals and milestones.
- ✓ Over 550 have been supported through a cycle.



- ✓ Structured six month programme, incorporates 2 residential elements
- ✓ Free to participants, thanks to the support of Department of Agriculture, Food and the Marine
- ✓ Focused on round tables of peers, facilitated by voluntary Lead Entrepreneurs
- ✓ Approximately 8 participants on each round table
- ✓ Lead Entrepreneurs are central to the selection of participants
- ✓ Feedback continuously collected

# Outcomes are extremely positive over the 10 cycles – on average after each cycle participants report:

- ✓ 50% more sales generated,
- ✓ 25% more employed
- ✓ Number of new exporters,
- ✓ Reduction in psychological isolation,
- ✓ Increase in confidence and motivation,
- ✓ Strong network created, with over 300 past participants actively engaged in the ACORNS Community



### **Outcomes of ACORNS 10 (52 Participants)**

- ✓ Participants recorded an increase of €1.5m over the six months to €4.3m
- ✓ There were 8 new exporters over the cycle
- ✓ There were 15 more employed by the participants at the end of the cycle
- ✓ 96% reported they made a decision for their business and 100% felt nearer to achieving their ambitions. 100% would recommend participating in ACORNS to others.



### **ACORNS Community**

- ✓ All participants, who have successfully completed a cycle, are invited to join the ACORNS Community, at no cost to them
- ✓ If trading, they are offered an opportunity to have their profile professionally written and to be involved in PR campaigns
- ✓ Invitations extended to Further Development round tables, topic based workshops and to annual Community Forum
- Those that wish to further grow their business are invited to compete to participate on ACORNS Plus and ACORNS Plus Review round tables

- ✓ Named runner up in European Promotion Enterprise Awards 2018, Investing in Entrepreneurial Skills
- In January 2025, the Director was invited by the Ambassador of Ireland to the Netherlands, Ann Derwin, to speak in The Hague as part of their St. Brigid's day programme
