- 3 main strands
 - \rightarrow Environmentally-friendly and nature-friendly agriculture
 - \rightarrow Climate-robust open space
 - \rightarrow Vibrant and vital rural areas
- Independent agency within the ministry of environment
- Rural policy unit
 - \rightarrow MA for LEADER in Flanders
 - \rightarrow Competent authority for rural policy in Flanders
- Flemish Minister for Interior Affairs, Urban and Rural Policy

Rural policies in Flanders: from integrated to casuistic policy and back

- Relative young policy field in Flanders (since 2004)
- Integrated rural policy
 - \rightarrow Rural policy plan
 - \rightarrow Intergovermental rural consultative body
 - \rightarrow Platform for rural research
- From 2016: more narrow interpretation of rural policy
 - \rightarrow 2019-2024 government: 3 focus areas + instruments
 - × Food and bioeconomy
 - × Landscape
 - × Vibrant villages
 - × Instruments: pilots, small project calls complementary to the CAP
 - \rightarrow Impact (?)
- New turning point: EU Long Term vision for Rural Areas, Siguenza conference and conclusions AGRI council (november 2023)





Start with demonstrating the need for an integrated and structured approach

• Linked with declining services (public transport, ATM's, local government services, local shops, ...)

First Rural Report 'The state of Rural Flanders' was published mid June '24


- Quantitative and qualitative analyses of different indicators on demography, economy, spatial planning & environment and administrative power
- Comparing rural with urban and peri-urban
- Demonstrating a clear need for structural rural policy

Government agreement 2024-2029

• We are drawing up a **cross-cutting rural pact** with comprehensive strategies and action plans to tackle the challenges facing rural areas and strengthen prosperity. In order to support community life and economic activity in rural municipalities, there is a need for adequate funding, guaranteed accessibility, assured services, utilities, incentives for economic growth and job creation, and room for self-development in a bottom-up approach at various levels of government and in various policy areas.

- 5 facets of Rural Flanders:
 - 1. A qualitative, resilient and multifunctional OPEN SPACE
 - 2. A vibrant, attractive and healthy LIVING ENVIRONMENT
 - 3. Warm COMMUNITIES
 - 4. A place of ECONOMIC ACTIVITY
 - 5. Governments and citizens WORKING TOGETHER
