

One Plan

- Simpler framework: simplified implementation, one set of rules, one programming
- Holistic, consistent and coordinated framework
- Reforms, **investments** and other interventions
- Enabling synergies
- More flexibility and adaptability

Comprehensive partnership

- Regional, local, urban, rural authorities (and other public authorities/associations representing such authorities)
- **Economic and social partners**, including farmers, fishers and their organisations
- Civil society, such as environmental partners, non-governmental organisations, youth organisations, and bodies responsible for promoting social inclusion, etc.
- Research organisations and universities, where appropriate

Tailored to MS' & regions' needs

- National, sectoral & regional and territorial chapters (depending on each Member State's administrative set-up, as is currently the case under cohesion policy/CAP)
- Tailored to each Member State's national and regional needs

NRPP specific objectives: rural areas

Art. 3 NRP Reg.

- (a) To support the Union's sustainable prosperity across all regions
- **(b)** To support the Union's defence capabilities and security across all regions
- **(c)** To strengthen **social cohesion** by supporting people and strengthening the **Union's societies** and the Union's social model
- (d) To sustain the quality of life in the Union
- **(e)** To protect and strengthen fundamental rights, **democracy**, the rule of law and to uphold Union values by

(i) Fostering the attractiveness of territories to support the right to stay including by supporting strategies for the integrated development of urban and rural areas, including support for territorial services and infrastructure.

(iii) Improving the attractiveness and living standards, including access to healthcare, in rural areas and fair work conditions and fostering generational renewal; improving farmers' preparedness and ability to cope with crisis and risks; enhancing the access to knowledge and innovation and accelerating the digital and green transition for a thriving agri-food sector



'Territorial' requirements for NRP Plans

- Reduce economic, social and territorial disparities in less developed, transition and more developed regions, including by
 - Allocate resources to the three typologies of regions according to their specific challenges (different national contribution rates: 15% / 40% / 60%)
 - Concentrating resources on less developed regions
 - Focusing on specific needs of border regions, northern sparsely populated regions, **rural**, island and outermost regions, urban areas, and areas affected by industrial transition
 - Strengthen economic and social development of outermost regions
- Effectively contribute to promoting the use of territorial and local cooperation interventions, including integrated territorial investments in ... rural and coastal areas, community-led local development or other territorial tools including just transition and smart specialisation strategies, LEADER

Examples of possible synergies

Education and skills



Today: several EU funds and spending programmes (CAP, ESF, Erasmus+) currently support education and training in rural and remote areas.

Tomorrow: Streamlined programming facilitates development of skills in rural areas allowing synergies between the EU and national funding and maximising impacts of EU spending.

Infrastructure / connectivity



Today: Synergies among EU programmes implemented and monitored separately are difficult to leverage in the absence of a coordinated effort at both national and regional levels.

Tomorrow: Single programming and governance system can boost holistic infrastructure build (broadband, backhaul, access networks) in remote areas so households/businesses can connect to high-capacity networks.

Integrated local development strategies/CLLD



<u>Today</u>: LEADER local development strategies under the CAP can support the provision of **social services** to excluded groups in rural areas (e.g. persons with disabilities, older people, youth, families at risk of poverty, etc.) <u>but...</u> use of multi-fund CLLD has been used only to a limited extend due to perceived administrative complexities.

Tomorrow: harmonised rules under the National and Regional Partnership plans can further facilitate synergies and complementarities with social and other policies.

Governance & networks

- Continuity and flexibility. Member States may retain existing governance bodies (managing authorities, paying agencies).
- Coordinating Authority: required if more than one managing authority/paying agency, ensuring national coherence.
- Monitoring Committees (+ coordinating committee): Member States can establish
 dedicated committee for sectoral / regional chapter, ensuring stakeholder involvement.
 New tasks include approval of selection criteria and territorial development strategies.
- EU and national CAP Networks facilitate stakeholder involvement, improves plans, and enhances exchange of best practices.



Territorial development tools

Territorial and local cooperation initiatives (Art. 74 NRP)

- LEADER as a type of community led local development
- Smart Villages

Integrated territorial and urban development (Art. 75 NRP)


- Based on integrated territorial development strategies
- Relevant also to CLLD focused on rural areas

Community-led local development (Art. 76 NRP)

- Focus on subregional areas, rural and coastal areas
- Carried out though integrated territorial development strategies
- Designed and implemented by LAGs

Support under LEADER (Art. 77 NRP + Art. 18 CAP)

- Mandatory for Member States
- Use of simplified cost options mandatory / encouraged





Monitoring spending and results 1/2

Budget tracking and performance framework Regulation

Establishes:

- a single system to track expenditure and performance of the EU budget
- a direct link between (1) what we finance (the intervention fields), (2) the contributions of those activities to horizontal priorities (green and social policies), and (3) their expected outputs and results, measured by means of 'performance indicators'
