Site visits organised by the Finnish Rural Network across Southeast and Southern Finland. The journey starts in Kotka at 08:30 and concludes at Helsinki Airport at 14:00 EEST. During the field visit, participants will explore the Finnish countryside and examine what **'Right to Stay'** means in practice from the perspectives of entrepreneurs and local communities as well as rural innovation, civil preparedness and security of supply.
